
Unistats Introduction

Purpose of Unistats website

Unistats is the official site that allows you to search for and compare data and information on undergraduate university and college courses from across the UK.

- It is owned and operated by:
- The Department for the Economy in Northern Ireland
- The Higher Education Funding Council for Wales
- The Scottish Funding Council
- The OfS took over from its predecessor, the Higher Education Funding Council for England, on 1 April 2018.

Purpose of Unistats website:




Unistats Widget

Allows providers and other organisations (UCAS, right) to display Unistats data on their own website.

Links to Unistats submission data by a unique identifier

Full time



Terminology:

- The Unistats collection used to be called "Key Information Set" or KIS – we still refer to:
 - KISRecord
 - KISCourse/KISCourseID
 - KISMode
 - KISAim
- Unistats submission the file a provider submits (an XML)
- Unistats system the system used to check and process the file
- The OfS Portal hosts the system, replaces the HEFCE Extranet

What goes on Unistats?

- From the submission:
 - Provider details
 - Location(s) of study
 - Basic course information (length, level, mode of study, sandwich year, year abroad, accreditations)
 - Links to the provider's website
- Linked data:
 - ILR data entry, continuation, degree results
 - NSS data student satisfaction
 - DLHE data employment/further study, common jobs, salary
 - LEO data

Changes to the Unistats collection for 2018:

- Official Statistics: Changes to data collection timetable
- Official Statistics: No provider preview of the Unistats website
- Official Statistics: NSS and DLHE results will not be in check documentation
- Changes to subject groupings used for Unistats website for the 2018 dataset
- Addition of Longitudinal Education Outcomes (LEO) data for English providers (already in 2017)
- Teaching Excellence and Student Outcomes Framework (TEF) Year 3 outcomes

Changes for 2018 - Subject groupings:

- Introduction of the Higher Education Classification of Subjects (HECoS) and Common Aggregation Hierarchy (CAH)
- This is a change to how the data is displayed on Unistats website and how data is aggregated by the system
- You can still use the Learn Direct Classification System (LDCS) codes in your submission
- You can also use HECoS codes if you wish but the Joint Academic Coding System (JACS) cannot be used in submissions this year

Changes for 2018 - Longitudinal Education Outcomes:

- LEO data will be displayed for each course according to the lowest publishable subject grouping it falls into on the CAH.
- LEO data is not produced at course level and is always aggregated over 2 years.
- For English providers only
- Replaces salary data from Longitudinal DLHE
- Median salaries are displayed for pay as you earn (PAYE) earnings data for the tax year three years after graduation

Changes for 2018 - Updating TEF Awards for Year 3:

- Already updated for Unistats 2017 collection (released 6th June 9:30)
- Will be included in Unistats 2018 from launch
- Awards from Year 2 that are still valid will continue to be displayed
- No differences in how Year 2 and Year 3 awards are shown on the website

Replacement of Unistats website


Following consultation on the outcomes of the Review of Unistats in 2015, the funding bodies are working together on options for a replacement for the Unistats website.

We will progress this work in stages – ensuring that it is developed in a way that meets the needs of prospective students across all countries of the UK – and will provide the sector with periodic updates, the first of which will be in summer 2018.

Coverage of the Unistats collection

What should be included:

Courses with start dates between 1 August 2019 and 31 July 2020

Undergraduate courses

First degrees, Integrated/Enhanced degrees, Foundation degrees, HNDs, Diplomas at undergraduate level

Linked to courses using the derived fields calculated by the OfS funding team

using data from the Learning Aims Reference Services (LARS) held by ESFA

Courses that are more than 1 year in length when studied full-time

Does not include HNCs or courses that are solely for **apprentices** (ILR Progtype 02, 03, 10, 20, 21, 22, 23 or 25)

Coverage of the Unistats collection: Franchise provision

Courses that are franchised in should be returned by the **teaching provider.**

Unless:

- The entirety of an provider's Unistats eligible courses are franchised in from a single other provider.
- Where a course is registered at one provider and the teaching is shared between both your provider and another provider.

In both of these cases, the Unistats record for the course(s) in question should be returned by the **registering provider.**

Coverage of the Unistats collection: Optional exit points

If students on a course can exit at different points with different types of qualification these are termed optional exit points

For example if students on a BSc Psychology course can choose to exit the course after 2 years with an HND.

If a student can only apply for the major award, even if they can leave with a lower award, then only one Unistats record is needed.

If students can apply separately for the lower award as well as the major award then a separate Unistats record would need to be produced.

(Provided that the lower award is still eligible.)




Exercise 1 Coverage

Coverage Exercises

Should these courses be submitted in a Unistats return? Should anything particular be noted?

- 1. A BSc Mathematics course which runs through a standard academic year for three years. This course is open to any UK students and is taught entirely in the UK.
- 2. A BSc Psychology course which runs from 24th September 2018 until 30th July 2021. This course is open to any UK students and is taught entirely in the UK.
- 3. A full-time Biology course taught as a Diploma at Level 7 (post-graduate). This course is open to any UK students and is taught entirely in the UK.
- 4. A part-time HNC in Engineering runs from 24th September 2019 until 30th July 2021. This course is open to any UK students and is taught entirely in the UK.
- 5. A HND Agricultural Studies course which runs from 24th September 2020 until 30th July 2024 at 0.5 FTE. This course is open to any UK students.
- 6. A provider has two eligible courses, a BSc Physics course and a BSc Chemistry course. Both are franchised in from the same registering provider.
- 7. A provider runs an Art course in which students can apply for either an integrated masters or a BA.



- There are rules to describe how the file must be structured
- You cannot submit and sign off a file that is not properly structured
- We recommend using the Data Entry Tool available from HESA's website

- Enter RECID of 18061 (2018/19 Unistats record)
- The tool will then guide you to enter all necessary data and create a valid XML



Provider entity > Location entity

Every location/campus at which students study in their first year.

Locations within 1KM are considered the same location:

• Should be represented by the major location of the two not somewhere between them.

LOCNAME:


Appears on Unistats

LOCID:

- 2 letters no numbers please
- Only appears on XML document, not on Unistats.

LATITUDE and LONGITUDE:

- Pinpoints location on map
- Can be found on Ordinance Survey website.



KISCOURSEID:

Unique identifier for each course

Advised to keep this the same each year if course doesn't change

UKPRN and KISCOURSEID used to display data in widgets



Provider entity > Course entity TITLE:

Combined with **KISAIM** and **HONOURS** fields to create title shown on Unistats.

Natural capitalisation and correct spelling

Should include only title and not:

- Qualification Aim
- Honours
- Other attributes: E.g.: Placement Year, Year Abroad, With a Foundation year.

4-year course, full time, year abroad (optional)

Provider entity > Course entity KISMODE:

Mode can be Full-Time (1), Part-Time (2) or Both (3).

Relates to the way in which the provider advertises the course.

"Both (3)" will create duplicate records, one for each mode.



Provider entity > Course entity DISTANCE:

Is the course available through distance learning?

Optionally available as distance learning (2),

Only available as distance learning (1),

Not available as distance learning (0)

Only **Part-Time** courses can have **DISTANCE** = 2

A **Full-Time** course available through both **DISTANCE** = 1 and **DISTANCE** = 0 will need to have two records produced for it.

Provider entity > Course entity

NUMSTAGE:

Captures the length of Full-Time courses only.

Sandwich years, foundation years and years abroad should be included in the total - if they are compulsory.

For courses that aren't in full years, the number should be rounded up.

NUMSTAGE should always be more than 1.

This replaced the **CourseStage** entity from 2017 onwards.

Provider entity > Course entity

Accreditation entity:

Records professional accreditations for the course.

ACCTYPE

- Body and type of the accreditation.
- Valid entries listed in the Coding Manual.
- These accreditations must be currently held or in the process of renewal and the accreditation must be in place in 2019/20 when the course begins.

CourseLocation entity:

This field picks up on the **LOCID**s previously set.

Used to show locations against individual courses.

If a course is available from multiple locations you should create multiple CourseLocation entities



Provider entity > Course entity

Additional course entity fields:

FOUNDATION:

• If the course includes an integrated foundation year.

SANDWICH:

• If the course includes an sandwich year in industry.

YEARABROAD:

• If the course includes year of study abroad.

All of these fields use the values Compulsory (2), Optional (1), Not available (0)

A note on URLs

URLs should be:

Active and updated throughout the Unistats Cycle

Relevant to the purpose of the URL

• Not a generic landing page


How should these Institutions return data in the provider entity?

- 1. What is wrong with including the qualification aim in the TITLE field?
- 2. A course is run both full-time over 2 years and part-time over 3 years with students able to apply for either option. The length of these courses is the only difference between them. What should be returned in the KISMODE field?
- 3. A part-time course has the option of being studied either distance learning or non-distance learning what should be returned in the DISTANCE field?
- 4. A part-time course is taught over 4 years. What should be returned in the NUMSTAGE field for this course?
- 5. A course has an accreditation which is only awarded to students who choose two particular optional modules. What should be returned in the ACCDEPEND and ACCDEPENDURL fields?
- 6. If the same course is taught simultaneously on two different campuses how many CourseLocation entities should be included?
- 7. If a course has the option of an additional sandwich year or year aboard which additional Course fields should be returned with value '1'?

Data linking



Why link to previous courses?

Links to previous iterations of the course are critical in displaying data on Unistats

This allows the system to pull in data from:

Student records (ILR returns or HESA Student Collection)

Used for: Entry Qualifications, Continuation, and Tariffs, Classification of degree

NSS results

Used for: Student satisfaction

DLHE survey results

Used for: Employment/further study, common jobs, salary data after graduation

LEO data

Long term median salaries for subject areas

Linking a 'KISCourse' to HESA or ILR data

HESACourse and ILRAims entities are not required for every KISCourse. The System will error if more than 1/3 of KISCourses are not linked.

They allow you to link a KISCourse to multiple courses run in previous years

If they exist, the expectation is that you would link to all previous instances of the course in 2014/15, 2015/16 & 2016/17 academic years

ILRAims must contain:

ILRAIMID and ILRYEAR

HESACourse must contain:

HESACOURSEID and HESAYEAR

Can also contain REGUKPRN if the course has been franchised in or TEACHUKPRN if the course has been franchised out

Changes to courses over time

If a course is new and has no data in 2016 or earlier, ILRAIMIDs and HESACOURSEIDs will not be able to pull in any data.

In this case, links are done using the values in the XML for:

- LDCS/HECOS
- KISMODE
- KISAIM

If a course has had a change of ILRAIMID it can still be linked back to.

- This could be because a course has changed slightly but is similar enough to link back to.
- The decision as to whether a course is similar enough to link back to is to be made by the institution.

When linking goes wrong

Links to previous courses are one of the most common causes of validation errors

If links are incorrect the data shown will be incorrect.

If there is not enough data the below message will display against the metric:

There is no data available for this course, as the course has either not run yet, or has not been running long enough for this data to be available. This does not reflect on the quality of the course.

This can however, be the result of inputting incorrect links to HESA/ILR courses.

UCAS Data

UCASPROGID (exists in the Course entity – one per course)

• A 6 digit code of the form A00-A00 or Z99-Z99.

UCASCOURSEID (exists in the CourseLocation entity – one or more per course)

• A 4 digit number between **0000** and **9999**.

The values for both of these fields should be held internally but should be available through the UCAS collection tool.

If the course is franchised in, the ID codes should be held by the registering institution.

Individual codes for each **KISMODE**.

Publication thresholds

Data displayed on Unistats for student records, DLHE, NSS or LEO must meet publication thresholds.

These are in place to ensure data is valid, meaningful and meets data protection criteria.

Source:	Applies to:	Threshold:
ILR/HESA data	All	At least 10 students.
National Student Survey	All	At least 10 responses and at least 50% response rate.
DLHE	All	At least 10 responses.
DLHE	UK, Full-Time	At least 68% response rate.
DLHE	UK, Part-Time	At least 59.5% response rate.
DLHE (Salary)	UK, Full-Time, Part-Time	At least 50% response rate (from employed graduates).
LEO	All (England only)	At least 15 students.


Aggregation

If data does not meet publication thresholds it will be aggregated.

Aggregation happens two over years and at each of the subject levels.

As different metrics have different publication thresholds, they may be aggregated differently.

Aggregation procedure





- 1. When should two UCASPROGIDs be entered?
- 2. Which years should a course be linked back to if possible?
- 3. A course is taught divided into 10 modules, 2 of which have changed since the instance of the course in 2015. How should this course be linked to NSS and DLHE?
- 4. If, for the NSS, there are 5 responses for a course in the current year and 4 responses in the previous year. And at subject level 3, there are 8 responses in the current year and 7 responses in the previous year. All response rates were above 50%. How will the data be aggregated?
- 5. A full-time course has a DLHE response rate of 67% at course level, 62% at subject level 3, 73% at subject level 2 and 70% at subject level 1 how will the data be aggregated?
- 6. The NSS data displayed for a course does not match the NSS data the course leader believes should be shown. What are potential reasons for this?
- 7. If the course has changed too substantially to link back to previous instances of it, which other fields should be populated to ensure data is shown?



The Validation 1 html document is a print out of HESA's validation kit.

• This contains the business rules.

It will include:

- Errors Which must be resolved.
- Warnings Which should be checked to ensure data validity.

Each will have:

• The rule that was triggered and its description

• An indication as to the part of the xml which triggered the rule

• The severity (warning or error)

• An indication as to whether the error is a schema or data error

Check documents 1 & 2

The check docs show the information that will be used on Unistats – they must be checked carefully.

Because of the changes due to OfS becoming a provider of official statistics Check Docs will be the only preview of the Unistats data.

Check docs will no longer contain the detailed NSS or DLHE results, but population information will be displayed to help identify missing data or linking problems.

Check doc 1 contains:

Locations submitted, courses that have not been linked to, institutions involved in teaching and registration, courses submitted, accreditations and links to provider websites.

Check doc 2 contains:

Entry qualifications data, Tariff data, Continuation data, Classification of degree data, NSS population data, DLHE population data.

Check doc 2 shows any aggregation used and displays data that will appear on Unistats.

The Sign-Off process

Valid data can be signed off after DLHE and NSS data is added in July.

The first sign-off must be completed by the Accountable Officer (usually the Head of Provider) using their own Portal account.

During the initial sign-off authority can be delegated so that further sign-offs can be completed by another member off staff.

Only in <u>exceptional</u> circumstances anyone but the Accountable Officer or their chosen delegate sign-off the data.

Accessing Sign-Off system

Valid data can be signed off after resubmitting a valid XML once DLHE and NSS data is added to the system in July.

Access to the system must be provided to the Accountable Officer by a User Administrator.

Once a valid submission has been uploaded. It can be signed off through the Unistats 2018/19 Sign-Off System:

Sign-off for the 2018-19 Unistats collection (Deadline: 17 August 2018 12:00) The system used to sign off valid Unistats data ready for publication on the Unistats website

Signing off the data

The Accountable Officer must log-in to the Portal using their own Portal account.

They must access the Sign-Off group and complete the sign-off process – instructions will be provided before sign-off opens.


Once this is complete the Accountable Officer will receive an email stating whether the Sign-off was successful or unsuccessful.
