## General ongoing condition A1: Provisional decision to approve an access and participation plan

I wrote to you on [date] to confirm that I had approved your 2020-21 access and participation plan. As set out in Regulatory notice 1,<sup>1</sup> the initial approval of an access and participation plan is for a period of one year. After this first year (2020-21), the approval of your plan will automatically roll over each year for a period of [x] years unless I expressly notify you in writing prior to this that a new plan needs to be submitted for approval.

I am writing to you now to confirm that the approval of your 2020-21 access and participation plan will roll over for the 2021-22 academic year on the same basis as your previous approval. Should your circumstances change during the academic year 2021-22 or if the OfS receives information to indicate that I may be unable to approve the plan for a further year, then I will expressly notify you in writing requesting that a new plan be submitted for the academic year 2022-23 onwards for approval.

I am aware that you recently requested to vary your plan. This letter does not constitute approval of your variation request, which is subject to a separate assessment and approval process. Until your variation request has been considered, your plan will, as set out above, roll over on the same basis as the one previously approved.
