# Summary

1. This document describes the 2020-21 Student Loans Company (SLC) comparison files generated by the 2020-21 HESA Student Alternative data checking tool and rebuild instructions. Throughout the document, fields taken or derived from the HESA Student Alternative record are shown in capitals.
2. The purpose of this comparison is to ensure that the 2020-21 HESA data is consistent with SLC records. For each provider, we check:
  - whether all students who received student support from the SLC during the 2020-21 academic year are included in the 2020-21 HESA data
  - whether all students who are recorded as receiving SLC tuition fee loans in the 2020-21 HESA data appear in the SLC data
  - whether all students recorded in the SLC data with a withdrawal date have a corresponding end date in the HESA data.
3. The 2020-21 SLC comparison can be used by higher education providers to verify and correct their 2020-21 individualised student data before signing off the final data with HESA.
4. The SLC comparison outputs are formed of two files. These are:
  - SLC comparison workbook 'SLCCOM20\_AAA\_XXXXXXXX.xlsx'
  - SLC comparison individualised file 'SLCCOM20\_AAA\_XXXXXXXX\_IND.csv'

where XXXXXXXX is your provider's eight-digit UK Provider Reference Number (UKPRN), and AAA identifies the output type as listed in the table below.

## 2020-21 SLC comparison individualised file

- When working through this document it is necessary to use the individualised file, SLCCOM20\_AAA\_XXXXXXXX\_IND.csv. The individualised file contains the values of all fields used to generate the SLCCOM20\_AAA\_XXXXXXXX.xlsx workbook 2020-21 SLC comparison figures.
- Fields taken from the HESA Student Alternative record or derived as part of the 2020-21 SLC comparison are shown in capitals using the names given in tables 2 and 3 respectively. Fields prefixed with 'SLCCOM' are derived, all others are taken directly from the HESA Student Alternative record, or SLC data, as indicated in Table 2.
- Specific instructions for rebuilding the 2020-21 SLC comparison workbook from the individualised file are provided in this document.
- The individualised file contains one record per instance (each unique combination of UKPRN, HUSID and NUMHUS) in the latest academic year. Additionally, the individualised file will contain one record per student as recorded in the SLC data, where that record has not been matched to an instance in the latest academic year.

16. The derived fields used to generate the 2020-21 SLC comparison are listed in Table 3.

### Instance period data

17. The number of instance periods that can be returned for a given instance is unbounded; however, due to file size considerations we restrict the number of separate instance periods displayed in the individualised file to three. In the unusual case where an instance has more than three instance periods, all will be considered in our algorithms, although only three will be displayed in the individualised file. In selecting instance period data to show we will first select those with the major source of tuition fees recorded as the SLC (MSTUFEE = 02, 03, 04, 52, 53, 54) and then those with the earliest period start date (PERIODSTART).

#### SLCCOMMSTUFEE1-3

18. These fields contain the major source of tuition fees (MSTUFEEs) that are associated with the instance.

#### SLCCOMPERIODSTART1-3

19. These fields contain the instance period start dates (PERIODSTARTs) for the student. For example, SLCCOMPERIODSTART1 will contain the instance period start date for SLCCOMMSTUFEE1.

## SLCCOMHESAPOP

20. This field identifies students who are in the HESA data for the provider.

## SLCCOMHESASLCPPOP

21. This field identifies students in the HESA data whose source of tuition fees is the SLC, in whole or in part.

1	Students whose source of tuition fees is the SLC	SLCCOMHESAPOP = 1, 2 and (SLCCOMMSTUFEE1 = 02, 03, 04, 52, 53, 54 or SLCCOMMSTUFEE2 = 02, 03, 04, 52, 53, 54 or SLCCOMMSTUFEE3 = 02, 03, 04, 52, 53, 54)

## SLCCOMSLCPOP

22. This field identifies students in the SLC data who were paid some student support in the 2020-21 academic year, and either did not withdraw within 14 days of the first term start date in that year, or else had their attendance confirmed during 2020-21.

## SLCCOMSLCFUND

23. This field identifies the streams of funding delivered to students from the SLC in the 2020-21 academic year.

1	Both tuition fee and maintenance funding were released on behalf of the student in the 2020-21 academic year
2	Only tuition fee funding was released on behalf of the student in the 2020-21 academic year
3	Only maintenance funding was released on behalf of the student in the 2020-21 academic year

## SLCCOMENDCHECK

24. This field identifies students in the SLC data with a withdrawal date where no ENDDATE or a later ENDDATE or an earlier ENDDATE is recorded in the HESA data.

Value	Description	Definition
1	Students who have a withdrawal date in the SLC data, but no ENDDATE is recorded in the HESA data	A record was found in the HESA data and SLCSSN ≠ BLANK and SLCWITHDRAWN_DATE ≠ BLANK and SLCWITHDRAWN_DATE < 01 August 2021 and ENDDATE = BLANK
2	Students who have a substantially later ENDDATE than the withdrawal date in the SLC data	A record was found in the HESA data and SLCSSN ≠ BLANK and SLCWITHDRAWN_DATE ≠ BLANK and ENDDATE ≠ BLANK and ENDDATE > SLCWITHDRAWN_DATE + 14
3	Students who have a substantially earlier ENDDATE than the withdrawal date in the SLC data	A record was found in the HESA data and SLCSSN ≠ BLANK and SLCWITHDRAWN_DATE ≠ BLANK and ENDDATE ≠ BLANK and ENDDATE < SLCWITHDRAWN_DATE - 14
0	Otherwise	Otherwise



## Rebuild instructions

25. The individualised file, SLCCOM20\_AAA\_XXXXXXXXX\_IND.csv, can be used to interrogate the data and our calculation of derived fields by filtering to certain groups of records.
