



What does the HESES24 workbook do?

- Gives an early indication of the number of higher education students studying in the academic year 2024-25
- It does this by:
 - **Categorising** students (today's webinar), and then
 - **Counting** them in their different categories (next webinar).


The HESES24 population



What is recorded in HESES?

- HESES counts '**years of engagement**' ('YoE')
 - An **engagement** is a student's commitment to an educational aim (qualification or credit) and its realisation over time.
 - Made up of one or more years of engagement
 - See our next webinar for more detail on what constitutes a year of engagement
- Note:
 - Before HESES23, we used to talk about 'years of instance'
 - You may see this term in older workbooks and documentation.

Working out who to include in HESES24



Who is included in the HESES24 population?

- See Annex A - students must be:
 - aiming for a **recognised higher education** qualification
 - or for higher-education-level credit that can be counted towards one
 - **registered** with a provider and actively pursuing studies in 2024-25 academic year
 - spending no more than half the active study time for their whole engagement outside the UK
- Notes
 - HESES24 counts **all** years of engagement in 2024-25 academic year, not just those for students starting their studies in 2024-25.
 - it's possible for one student to generate more than one year of engagement (although this is rare and limitations may apply: see the HESES guidance).

Definition of recognised higher education

A course is recognised higher education for OfS funding purposes if it is:

- a course that is designated under the Education (Student Support) Regulations 2011
- a ‘course of higher education’ as defined in Schedule 6 of the Education Reform Act 1988, other than one leading to a qualification in the Register of Regulated Qualifications.

Study for higher education level credit may also be included if it meets the criteria in Schedule 6 of the Education Reform Act 1988 and **either**:


- it is not credit that may count only towards a qualification in the Register of Regulated Qualifications
- it is credit that may count towards a course that is designated under the Education (Student Support) Regulations 2011.

HESES24 guidance document – annex B

Higher Technical Qualifications (HTQs) in HESES24

- We collect data on students on some courses leading to HTQs
 - used in calculating additional funding for eligible courses
 - collected in Table 5 of the HESES workbook
- Being an HTQ is not sufficient on its own to be included
 - only those approved by the **Institute for Apprenticeships and Technical Education** (IfATE) *may* be eligible to be recorded if they meet the Annex B criteria.

Working out who to include in HESES24



Which years of engagement to count in HESES24

- To be counted, years of engagement for 2024-25 must meet all these criteria:
 - A fee must be charged – see Annex C for more detail
 - The student is not ‘writing-up’ throughout the entire year
 - The student has not withdrawn (and is not forecast to withdraw), within two weeks of starting their engagement.
- There will be more about **how** to count years of engagement in the next webinar.

Who is included in the HESES24 population?

- See Annex A - students must be:
 - aiming for a **recognised higher education** qualification
 - or for higher-education-level credit that can be counted towards one
 - **registered with a provider and actively pursuing studies in 2024-25 academic year**
 - spending no more than half the active study time for their whole engagement outside the UK
- Notes
 - HESES24 counts **all** years of engagement in 2024-25 academic year, not just those for students starting their studies in 2024-25.
 - it's possible for one student to generate more than one year of engagement (although this is rare and limitations may apply: see the HESES guidance).

Students ‘registered with a provider’

- Students should only be returned in HESES24 by the provider that they are **registered** with
- This is the provider which has the ‘full contractual responsibility to the student for the provision of educational services’
 - the registering provider is the one that has tuition fees paid to them (usually by the Student Loans Company)
 - for students on apprenticeships, this is the same as the lead provider for the Education and Skills Funding Agency (ESFA) i.e. the provider that receives the apprenticeship funding from the ESFA
- Further guidance on this, including on joint courses and exchange students, is in Annex A of the HESES guidance.

Validation and sub-contracting

- Where providers are in a partnership, this could be:
 - **Validation arrangement** (awards made are ‘validated’ by another provider)
 - students are registered with the teaching provider which will report them in its data returns
 - **Sub-contractual (‘franchise’) arrangement**
 - students are **not** registered by the teaching provider
 - the teaching provider is teaching on behalf of the registering provider
 - in this case the teaching provider does **not** report students in their data returns
- For further information, please see the HESES guidance (Annex A).

Notes on apprenticeships



Some students may be taking their higher education qualification as part of an **apprenticeship**:

- They should be registered with and reported by the lead provider (usually contracted by the ESFA)
- We only fund activity related to the higher education course
- They are not considered to be closed courses
- They are reported in HESES the same as any other student
 - no additional data is being collected on degree apprenticeship courses in HESES24.



Mode (Annex D)

- Determines which table to record a student on in the HESES workbook
 - full-time: Table 1
 - sandwich year out: Table 2
 - part-time: Table 3
- Mutually exclusive
- (The other tables shown here analyse the same data in different ways – more on these later.)

Table name	Mode recorded
Courses*	All
1: Full-time	Full-time
2: Sandwich	Sandwich year out
3: Part-time	Part-time
4: Year abroad	Full-time and sandwich year out
5: Planning	All
6a and 6c: Health	All

* Courses table: Further education and sixth-form colleges & academies only.

Mode: full-time (Table 1)

- Full-time fees are chargeable
 - fees can be waived, but there are restrictions on this (see Annex D)
- Normally required to **attend** for at least **24 weeks in the year** of engagement at a specific location
 - at the provider or somewhere else (e.g. sub-contracted location)
- Undertake study, tuition, learning in the workplace, work placement for an average of at least **21 hours per week**
 - Can include time spent on a sandwich work placement, **if** the year doesn't meet the criteria to be a sandwich year out.

Mode: sandwich year out (Table 2)

A year of engagement is counted as a sandwich year out if it includes a period of work-based experience **and** it meets these criteria:

- A reduced fee is chargeable
- Meets the definition given in the student support regulations **OR** is an Erasmus year abroad spent working
- Meets the time-based criteria in Annex D
 - No more than 10 weeks of full-time study **OR**
 - The total of all the time spent not in full-time study (e.g. work placement) goes over 30 weeks

Examples given in Annex D.



Mode: sandwich year out – example

- Year 1
 - 15 weeks of full-time study + 16-week placement
 - Mode is **full-time** because:
 - full-time fees are chargeable
 - required to attend for at least 24 weeks
 - **study**, tuition, learning in the workplace, **work placement** for at least 21 hours per week
- Year 2
 - 15 weeks of full-time study + 16-week placement
 - Mode is **sandwich year out** because:
 - total time so far **not** in full-time study > 30 weeks (two 16-week placements = 32 weeks).



Mode: part-time (Table 3)

- If a year does not meet the definitions for:
 - full-time or
 - sandwich year out
 - then **for HESES purposes** it is considered **part-time**.
- Mode can change between years
 - More detail and examples are in Annex D

Mode: different definitions

- ‘Full-time’ as recorded on the relevant individualised student data return may not be the same as HESES full-time
 - Example: a student studying full-time on a 15 month course. In their second year of engagement (the last three months) they would be studying at a full-time intensity (greater than 21 hours a week) but would be attending for less than 24 weeks.
 - This would make them part-time for HESES, but full-time for the individualised data return.
 - **ILR:** use MODESTUD=3
 - **Data futures:** use SCSSMODE=02 (Other full-time).
- Refer to the ‘Additional guidance on mode of study’ section in Annex D of the HESES guidance.

Recording mode for apprenticeship students



Some students may take a higher education qualification as part of an **apprenticeship**:

- we only fund activity related to the higher education course
- therefore usually part-time
- must satisfy additional criteria to be recorded as full-time
 - see the HESES guidance Annex D.

Price groups – what are they?

Years of engagement are assigned to one of six **price groups** reflecting the costs associated with particular subjects:

- **A:** clinical years of medical, dental and veterinary courses
 - **B:** laboratory-based subjects e.g. chemistry, engineering, certain health care courses
 - **C1.1:** strategically important intermediate cost subjects e.g. pre-registration courses in nursing, computing and information technology, and archaeology
 - **C1.2:** other intermediate cost subjects covering provision in performing and creative arts and media studies
 - **C2:** subjects with a laboratory, studio or fieldwork element e.g. geography, languages, psychology
 - **D:** classroom-based subjects e.g. politics, economics, law, English, history
- These are used in calculating grants for various funding allocations.

Price groups – choosing the correct price group

- How are courses assigned to price groups?
 - “specific cases”
 - according to a coding system
 - **HECoS**: Higher Education Classification of Subjects
 - Used by **all** providers – FECs used to use LDCS (LearnDirect Classification System)
 - Full description in the HESES guidance (Annex G).
- Important to get right
 - may be queried in HESES data verification

Price groups – ‘specific cases’

There are **specific cases** where the price group is pre-defined:

- sandwich years out
 - clinical years of medical, dental and veterinary science courses
 - pre-registration courses in nursing, midwifery and allied healthcare
 - pre-registration courses in social work
 - initial teacher training courses
 - full details in Annex G of the HESES guidance
-
- If not a special case, use HECoS codes to determine price group.

Price groups - HECoS codes

- HECoS is a way of classifying areas of study for use in data surveys
 - administered by the Higher Education Statistics agency (HESA)
 - see hesa.ac.uk/support/documentation/hecos
 - has tables showing the complete list of HECoS codes
- HECoS codes are mapped to the price groups used in HESES
 - see Annex A of 'Data collection to inform funding for 2022-23: Notification of changes' (**OfS 2021.32**).

Which HECoS codes, which price groups?

- HESA has produced guidance for assigning HECoS codes to courses:
 - www.hesa.ac.uk/support/documentation/hecos
 - ‘The qualification subject(s) must represent directly, or relate very closely to, the wording on the qualification’s official certificate of award. More than three qualification subjects would generally be regarded as exceptional.’

Price groups for FECs: using the Courses table

- The Courses table maps learning aim references to price groups using this data

Price group splits

- Years of engagement can be split between price groups, if the course is associated with two (or more) HECoS codes
- Activity is split between price groups reflecting how much activity they do in each, **based on the course as a whole**
 - i.e. each year would have the same split of price groups.

Price group splits – example

BSc physics with maths (three-year course): associated with two HECoS codes:

- 100425 (physics) – maps to price group B
- 100403 (mathematics) – maps to price group C2
- Course breakdown:
 - Year 1 – physics 60 per cent, maths 40 per cent
 - Year 2 – physics 40 per cent, maths 60 per cent
 - Year 3 – physics 80 per cent, maths 20 per cent
 - **Average** = physics 60 per cent, maths 40 per cent
- In HESES, **all years of engagement** would be recorded with this 60-40 split.

Length: standard and long years



Long years

- Full-time students – where a student is **in attendance for 45 weeks or more** in the year of engagement
 - Some restrictions:
 - periods of work experience don't count
 - sandwich years don't count
 - (usually) foundation degrees don't count
 - Part-time students – depends on the length of the equivalent full-time course: see Annex H for full details

Standard-length years

- If not a long year, it's a standard-length year.





Home fee – as defined by the fee regulations

- From 1 August 2022, following changes to legislation, includes further categories of students eligible for home fee status
- May also include some EU students covered by the withdrawal agreements
- Further changes in recent years; our annual ‘Changes’ document signposts these
 - See OfS 2024.37 is the most recent
- Refer to Student Finance England (SFE) regulations for full details (links in annex F).


Overseas – those outside the definition of home fee status

- Not included in funding allocations but we still count them

- Note: the HESES guidance is **not** definitive – refer to the SFE fee regulations.

Fundability status – fundable or non-fundable?

OfS-fundable:

- Home fee students **unless** they are in one of the categories below.

Non-fundable categories (see Annex F for the full list):

- postgraduate research (PGR) students
- initial teacher training (leading to QTS/EYTS) and INSET students
- certain courses commissioned and funded by an NHS organisation
- PGT students funded by another public source
- students on closed courses (**not** students on apprenticeships)
- students aiming for equivalent or lower qualifications (ELQs), unless exempt
- some health-related courses started before funding was transferred from DHSC.

Fundability status: ELQs (1)

Equivalent or lower qualifications (ELQ):

- When students are aiming for a qualification that is at the same level (or lower) than one they have already achieved
- **Generally non-fundable** but there are some exemptions. See HESES guidance Annex F for the full list, but examples are:
 - foundation degrees
 - PGCEs
 - students in receipt of Disabled Students' Allowances
 - a number of health-related courses
- If you don't know a student's prior qualifications, treat them as aiming for an ELQ. (i.e. non-fundable, unless exempt).

Fundability status: ELQs (2)

Note:

- Students can be aiming for more than one qualification as part of the same course, e.g. an HND and a degree.
 - For ELQ purposes, assess status against the LOWER qualification
- ELQ is a concept used by some other organisations but be aware that their definition may be different from ours.


